- Annual Reporting of Kentucky Tourism Development Act Incentives Pursuant to Subject: KRS 148.8591

For the fiscal year ending June 30, 2024, the Department of Revenue's Division of Sales and Use Tax approved 27 tourism refunds totaling nearly \$11.6 million. The table below provides the amount awarded each fiscal year since the program's inception for a total of \$130 million.

During FY 2023-2024, there were nine applications submitted and granted preliminary approval by the Kentucky Tourism Development Finance Authority (KTDFA). At the time of the application, the total estimated investment was nearly \$463.3 million with a maximum potential incentive of \$115.8 million, 25 percent of eligible costs.

During FY 2023-2024, there were nine projects granted final approval by the KTDFA. In total, these nine projects represent \$284.4 million in potential investment. As certified by the Finance and Administration Cabinet and the Office of the State Budget Director, the maximum possible incentive combined for these projects is \$36,472,000.

Of the fourteen projects that received either preliminary or final approval during FY 2023-2024, four received both.

The table below shows the projects that received either preliminary approval, final approval or both during FY 2023-2024, with the date highlighted in green.
