Request for Transfer of Incentives Musselman Hotels, LLC

Date June 26, 2024

Location Newport (Campbell County)

Project Description

Musselman Hotels, LLC received final approval from the Authority in April 2014 for the construction of the Aloft Newport on the Levee, a full-service lodging facility. The project was constructed and is currently receiving incentives.

The property will be sold to Rolling Hills Newport II, LLC and the original applicant is requesting a transfer of the remaining incentives to the new owners.

Approval of Transfer

By approving this transfer, the KTDFA would enable staff to prepare and issue an amended Tourism Development Agreement for the new owners, Rolling Hills Newport II, LLC.

Request for Preliminary Approval 401 W High Street LLC

Date June 26, 2024

Location Lexington (Fayette County)

Project Description

The Applicant is proposing a full renovation of the Hyatt Regency Lexington. The property is connected to the Center Bank Center and is applying as integral part of a major convention facility.

The total estimated project cost is \$66 million. The maximum potential sales tax rebate, up to 25 percent of project costs, is estimated at \$16.5 million.

Development is slated to begin in September 2024 and target completion is March 2027.

Type of Tourism Development Project

This project applied as a full-service lodging facility integral to a major convention center.

The Applicant indicated that the project will meet the following criteria:

- Total eligible costs shall exceed \$6 million.
- In any year, including the first year of operation, the tourism development project shall be open to the public at least 100 days.
- In any year including the first year of operation, the lodging facility shall attract at least 25 percent of its visitors from among persons who are not residents of the Commonwealth.

Preliminary Approval

By granting preliminary approval, the KTDFA would enable staff to engage the consultant to develop a proposal to estimate the net positive fiscal impact to the Commonwealth and the expected amount of incremental state revenues generated by the tourism development project. The consultant will work with staff as well as the Office of the State Budget Director and the Finance and Administration Cabinet to set the methodology and assumptions to be used in the report.

Request for Cost Certification 900 Baxter LLC

Date June 26, 2024

Location Louisville (Jefferson County)

Project Description

900 Baxter LLC received final approval from the Authority in May 2021 for the construction of a 65 room, full-service boutique hotel in three historic buildings. The project includes a chefdriven restaurant, bakery café, corner bar and outdoor courtyard with a swimming pool.

The Myriad Hotel opened for business in the fall of 2023 and is requesting the certification of its capital costs to construct, equip and install the tourism development project. They submitted nearly \$16.8 million in costs. After review and consultation with the applicant, \$14.8 million are considered approved.

The Office of the State Budget Director and the Finance and Administration Cabinet determined, based on the consultant report, that the total incentives to the project should not exceed \$2,896,000 over the ten year term of the agreement. Therefore, the maximum amount of approved costs to be certified is \$11,584,000.

The completion date is December 31, 2023.

Approval of Cost Certification

By approving the costs and completion data, the KTDFA would enable staff to inform the Department of Revenue that this project is approved to receive incentives of \$2,896,000 over the ten year term of its agreement beginning January 1, 2024.
